



AREA OF ACTION

STRATEGIC BENEFITS DERIVED FROM THE CREATION OF CREHO

- Positioning of the region in the development of actions related to wetlands via exchanges, capacity building, broadcasting and others.
- Increased visibility of key players at the local, national and international level, particularly in the Western Hemisphere, with global reach through the various networks where CREHO is a participant.
- Incidence of CREHO in matters related to capacity building and research for the 29 countries with which it must work in the Western Hemisphere, with the ensuing visibility and projection of the region as the first Ramsar Regional Center and the promoter of this initiative.
- Fulfillment of the commitment made by Panama at the COP7 of the Ramsar Convention and the Central American Commission of Environment and Development, providing Panama and the region with credibility in terms of their capabilities, seriousness and leadership and demonstrating effectiveness in comparison with other initiatives relating to the environmental sector.
- Facilitate the establishment of strategic alliances with similar initiatives, which will increase the impact of CREHO's actions and the projection of the region in international forums throughout the Americas and other regions of the world.









CREHO IN THE AMERICAS: ADVANCES AND ACCOMPLISHMENTS

Since 2004, by fulfilling its goals and implementing its strategic action lines, CREHO has engaged more than a thousand key stakeholders and reached a significant number of people in the community at large, thus building a critical mass in support of the importance of the conservation of wetlands and increasing knowledge about the Ramsar Convention and its technical guidelines for the implementation of conservation and management measures upon wetlands.

Through its actions, CREHO has promoted knowledge and use of some of the main Ramsar resolutions and guidelines, such as wise use, management, inventory, environmental impact evaluation, wetlands committees and policies, and CEPA.



CREHO has diversified the means it uses to increase its presence and to position the wetlands issue in key sectors, taking advantage of existing forums and other instances, thus avoiding duplication of efforts and making the most of its interventions by supporting existing processes, initiatives, players, and resources in the region.













HISTORICAL SUMMARY 2004 — 2009

Strategic Objective 1

Generate knowledge through research and studies on wetlands management and wise use, bearing in mind the biodiversity and benefits to the human populations of the hemisphere.



- In 2006, responding to a request by the USFWS, CREHO carried out an evaluation of the application of Resolution VIII.45 "Functioning of the Conference Contracting Parties and Efficacy of the Ramsar Resolutions and Recommendations" using a small sample group comprised of Panama, Colombia and Costa Rica. The study showed that Panama required support to increase its knowledge of the Ramsar Convention and guidelines. Thus, from 2007 on, CREHO started implementing activities geared towards the development and strengthening of technical capabilities through local training and by supporting the participation of Panamanians in international courses organized by CREHO. It has also collaborated to increase knowledge about the Ramsar Convention guidelines through specific facilitating activities, such as the establishment of the Panama's National Wetlands Committee, the elaboration of the first continental and coastal wetlands inventory and the formulation of wetlands national policy. All this actions implemented by the Center have been in partnership with ANAM.
- Preliminary Inventory of Panama's Continental and Coastal Wetlands. Coordinated with ANAM within the framework of the Panama National Wetlands Committee. Funds provided by the AVINA Foundation (October 2006-March 2009); printing of 1000 copies funded by Movistar-Panama, and 500 digital copies on CD founded by STRI, WI, and CBMAP (December 2009).



Strategic Objective 2

Prepare human resources through training and educational programs, seeking to expand theoretical and practical knowledge of wetlands.


CREHO has trained 262 professionals and technicians linked to wetlands, both from the governmental sector (including an important percentage of Ramsar focal points, who received full scholarships to attend courses and workshops) and from the civil society. particularly NGOs, academia, and the private sector. Of these participants, 108 attended six international specialized courses (Mexico 2004, Panama 2006, Panama 2007(2), Panama 2008 and Costa Rica 2008); the participants hailed from 28 countries in the Americas, and one from overseas. The remaining 154 attended national courses (Panama and Colombia) and workshops (Costa Rica), which were more general in character and nationally targeted. The instructors came from 12 countries, 8 from America and 4 from Europe (according to the location of their main offices). Lecturers have come from 12 countries, 9 from the Americas and 3 from Europe.






GRAPHIC 2. PERCENT OF ATTENDANCE BY TYPE OF INSTITUTION

GRAPHIC 3. PERCENT OF TOTAL ATTENDANCE BY GENDER





- CREHO has also participated as lecturer in courses organized by other institutions, thus reaching 230 people in four events: one, national (Panama) and three, international within the United Nations framework (New York, Panama and Argentina).
- Through 15 promotional events CREHO reached 1,900 people: four, national (Panama); four, international (organizations with offices in Panama); two, side events at the COP 9 Ramsar; three, national wetlands symposia (United States, Ecuador and Korea, within the framework of the East Asia Regional Center), and two international wetlands symposia (Ecuador and Taiwan).
- CREHO participated in 23 different workshops and meetings on wetlands issues organized by other organizations; eleven, national (Panama, due to the Center's location); five, international (hosted by organizations located in Panama) and seven, international (México-UNDP, Costa Rica-WHMSI, The Netherlands, Ramsar Advisory Committee on Capacity Building, Uganda (2) COP9, Bolivia-OAS/WHMSI, Kenya-CMS). Most national events taking place in Panama were organized by ANAM, STRI and the Global Compact Network, while the international events that took place in Panama were organized by Cathalac and IABIN (Inter-American Biodiversity Information Network).
- CREHO has provided support to four national events celebrating environmental issues. Through environmental education, it supported a local festival dedicated to highlighting the importance of water, the "Blue Gold Festival". These promotional activities reached hundreds of people, including some 300 children of varying ages, with a positive message.



IMPACTS IN THE REGION FROM CREHO'S INTERVENTIONS TRAINEES APPLYING AND REPLICATING THE KNOWLEDGE ACQUIRED

In 2008, CREHO started following up on the people who had attended the training courses it had coordinated, in order to verify how the knowledge acquired and the tools provided were being applied and/or replicated to issues pertaining to wetlands conservation. Preliminary results attest to the usefulness of the knowledge acquired and show the cascading effect of CREHO's interventions.

- With respect to the World Wetlands Day up to now, the majority of efforts have mainly focused on Panama. Before CREHO came into existence, the day was celebrated by a local NGO. In 2004, members of the Board of Directors indicated that CREHO must promote and become directly involved in this celebration; thus, in 2005, CREHO organized its first event, where more than 150 children participated and some 50 people attended the conferences. Other players came into play in the following years as co-organizers, ANAM and the National Wetlands Committee among others, which has contributed to the local promotion of this important date. At the regional level, each year CREHO dedicates an issue of its informative bulletin, Infowetland, to celebrate the date and provides the Ramsar Convention Secretariat support as needed.
- CREHO also produces, and collaborates with the production of, bibliographic material, information and documents geared towards a very diverse public; of special importance is the collaboration with three publications and the participation as a panelist in four television programs (three locally transmitted and one transmitted to eleven countries in Latin America). INFOHUMDEAL, a quarterly electronic bulletin, produced since 2006 both in Spanish and English, currently has over 600 subscribers in different regions of the world, and CREHO's Webpage (www.creho.org) includes interactive tools such as the portal for the Ramsar Convention members from the Americas, as well as spaces for individuals to make their causes and wetlands known.



Strategic Objective 3

Implementation of the objectives of the Strategic Plan of the Ramsar Convention, by promoting scientific and technical cooperation and the exchange of experiences in the use and conservation of wetlands in the Western Hemisphere and other regions of the world.



- National and regional networks, other initiatives:
 - CREHO actively participates in the Western Hemisphere Migratory Species Initiative (WHMSI). It has supported the promotion of this initiative at many forums, as well as the creation of its Website as another promotion tool.
 - Waterbird Conservation Council for the Americas: CREHO joined through an invitation to Rosa Montañez, in order to offer training support. The first workshop aimed at monitoring waterfowls in Central America and Colombia has taken place and other funding sources are being accessed to support training activities to be carried out by CREHO.
 - Panama's National Wetlands Committee. CREHO provided support for it to be formally recognized by ANAM; since its inception, CREHO has made efforts to empower key players within the committee; the lessons learned through this experience will be systematized in order to be able to replicate the process in other countries.
 - US National Wetlands Committee. Participation in one meeting and exchange of information and communications. Both the Committee and CREHO have suggested ideas for a closer relationship between them.
 - International Network for Sustainable Development (CIDES). CREHO is one of the founders organizations since 2004; the network is located at the City of Knowledge and is at an evolutionary stage.
 - Wetlands Link International, a member since 2005; CREHO has asked for its support to design a wetlands interpretative center.
 - The Nature Conservancy Learning Center; in 2005 an agreement was signed but is not currently active.
- Wetlands Documentation Center, specialized library for the public; it opened in 2007, with donations from IUCN-ORMA
- Strategic alliances: agreements with City of Knowledge, Cathalac, IUCN-ORMA, United Nations Global Compact (Panama Chapter).

- Ramsar Convention regional initiatives:
 - High Andean Wetlands Strategy. CREHO is a member of the contact group since 2004. It has participated in all of the meetings, providing concrete support; it has promoted the initiative's strategic objective targeted at training in different forums and has supported it in fundraising efforts for its implementation.
 - Cuenca del Plata Initiative: CREHO was invited to become a member of the contact group in 2007, during the Ramsar Panamerican meeting.
 - Mangroves initiative: CREHO was invited to become a member of the contact group.
- Ramsar Convention:
 - Follow up to the issue of regional initiatives and the financial support they provide CREHO; participation in three meetings of the Ramsar Standing Committee (31, 34, and 36) and two Conferences of the Parties (COP9 Uganda, COP10 Korea), in the latter, CREHO carried out its first side event in a COP).
 - Member of the Supervisory Group of the Public Communication, Education and Awareness Program (CEPA) 2006-2008, which produced the 2009-2015 CEPA Program, Ramsar Resolution X.8.
 - Participation in meeting of Advisory Board on Capacity Building for the Ramsar Convention, Delf, 2007, a workshop that provided inputs as guidelines for the Convention.
 - Ramsar fundraising projects for Wetlands for the Future; participation in project events approved for other organizations (Guatemala/MAP and Costa Rica/Fungap).
- Other supports:
 - Additional support has been provided through technical guidance and contacts with key players in the region. Worth mentioning is the support provided to ANAM to identify the threats and priorities concerning wetlands, which was the basis for a proposal elaborated by the Panamanian government to the GEF.



Strategic Objective 4

Achievement of financial self-sufficiency, human resource capability and administrative efficiency.



- The Panamanian Government, by Law #33 of July 7th, 2004, assigned legal status to CREHO under the category of international organization, thus providing the recognition needed to operate as a non-profit entity.
- Board of Directors working and evolving.
- Basic operational personnel: five civil servants, one external auditor and a platform of specialists hired by project according to needs.
- Financial and accounting systems operating, with patrimony, operational and administrative reserves, contingency reserves and provision for seniority primes and compensations.
- Planning systems: strategic plan and operational plans (2004 and annual updates).
- Institutional evaluation system: Institutional Development Framework (IDF) applied in 2004, 2006 and 2009 as the baseline to measure institutional development.
- Administrative systems: Administrative Handbook (2004, with reviews in 2005 and 2006); Board of Directors Internal Regulations (2004, with reviews in 2005 and 2006); Guide for Board of Directors Meetings (2006); Guidelines for Communications and Brand (2006); Guidelines for Infowetland (2006 and 2009).
- Mid-term strategies: fundraising strategy (2006), communications strategy (2006).
- Diversification of income sources, both in cash and in-kind; generation of 1:1 resources to complement those from ANAM and the regional initiatives, which has meant additional activities to reach the goal.

MAIN FINDINGS USED BY CREHO TO JUSTIFY ITS INTERVENTIONS

In order to establish the work agenda, CREHO used the main findings regarding the wetlands situation in the region for the period 2004—2006.

- Little knowledge about the Ramsar Convention.
- Limited understanding of concepts such as "wetlands" and "wise use" and generalized lack of knowledge about the usefulness of wetlands.
- Approximately 50% of internationally important wetlands in the Western Hemisphere were without management plans.
- Less than 50% of Ramsar Convention member countries in the Western Hemisphere had Wetlands National Committees.
- Less than 50% of Ramsar Convention member countries in the Western Hemisphere had Wetlands National Policies.
- Legal vulnerability of international important wetlands without management category assigned to them.
- Limited resources to implement conservation activities in wetlands of international importance, in particular, and wetlands, in general.
- Lack of knowledge regarding current situation of wetlands and the economic value of goods and services provided by them.
- Partial information regarding wetlands inventories at regional and local level.
- Accelerated loss of wetlands through infrastructure development, over use of water and biodiversity resources, transformation of soil use for productive activities.


CREHO'S INTERVENTIONS APPROACH

CREHO defined the key elements of its actions on the basis of the findings made:

- Three (3) lines of action: training, research and cooperation. With emphasis in training.
- Eighteen (18) thematic lines for capacity building, grouped into three priority segments directed at key groups. The primary objective has been to provide wetlands management, environmental impact assessment, and environmental strategic assessment.
- Three (3) areas of direct incidence: wetlands national policies, national wetlands committees and wetlands of international importance integrated management.
- Priority geographic areas to develop specific activities in order to promote the conservation and wise use of wetlands.
- Support to regional initiatives being developed, with emphasis in capacity building (Strategy for Conservation and Sustainable Use of High Andean Wetlands, Central American Policy for Conservation and Wise Use of Wetlands, Western Hemisphere Migratory Species Initiative WHMSI, Waterbird Conservation Council for the Americas, and the recent regional initiatives in progress: mangroves and Cuenca del Plata).
- Synergies and alliances with key players (Ramsar Convention partner organizations, regional offices of other environmental agreements, other specialized organizations with presence in wetlands in the region).




RAMSAR REGIONAL CENTER STRATEGIC FRAMEWORK



The Ramsar Regional Center Strategic Framework is a key tool that shows in organized and easy to understand manner the lines of action that guide the activities in which CREHO is involved. The different actions that CREHO undertakes for wetland conservation are based on their relevance with respect to the objectives that are presented in this framework.

The strategic framework was developed from the functions given to CREHO when it was created by the instrument that legally constitutes it (Law no. 33, 7 July 2004 'In which it's approved the agreement signed between the Government of the Republic of Panama and the Convention on Wetlands of International Importance especially as Waterfowl Habitat for the for the creation and functioning of the Ramsar Regional Center for Training and Research on Wetlands in the Western Hemisphere, signed in Gland, Switzerland, February 28th, 2003").



FIRST LINE OF ACTION

RESEARCH

Strategic Objective 1

Generate knowledge through research and studies on wetlands management and wise use, bearing in mind the biodiversity and benefits to the human populations of the hemisphere.



SUB-OBJETIVES

1.1 Promotion and coordination of scientific research and study in the region in order to expand knowledge of wetland functions and values, their biodiversity and indicators of ecological characteristics, and also regarding the economic valuation and management of these ecosystems with the purpose of promoting their sustainability and conservation.

1. 2 Developing assistance and consulting activities aimed at the study and management of wetlands.

	EVALUATION OF THE APPLICATION OF RESOLUTION VII.45
2006	With the support of the US Fish and Wildlife Service, CREHO carried out an evaluation of the application of Resolution VII.45, "Functioning of the Conference of Contracting Parties and Efficacy of Ramsar Resolutions and Recommendations" in Panama and Colombia. The evaluation evidences a need for additional action in Panama to increase the knowledge about the Ramsar Convention and its guidelines.
2007	Thus in 2007 in conjunction with ANAM, efforts specifically directed at increasing knowledge began to develop and strengthen capacities in Panama through training and precise actions of facilitation.
	PRELIMINARY INVENTORY OF PANAMA'S CONTINENTAL AND COASTAL WETLANDS
2008	In October 2007, within the framework of the Panama's National Wetlands Committee, CREHO in cooperation with ANAM started the elaboration of a preliminary inventory of wetlands in Panama. Funds were provided by the AVINA Foundation.
2000	The approach that was used for the elaboration of the inventory of wetlands was classification by ecosystemic type. In 2008, the field work and the systematization of the collected data was initiated.

PUBLICATION OF FIRST INVENTORY OF PANAMA'S CONTINENTAL AND COASTAL WETLANDS

On May 2009, in coordination with the National Environmental Authority and thanks to the financial support of AVINA Foundation, the project came to a fruitful conclusion. The resulting document was consulted and reviewed by members of the Panama National Wetlands Committee and, later, the book entitled "*Inventory of Panama's Continental and Coastal Wetlands*" was edited for publication.

On December 2009, the first 1000 copies were printed thanks to funds provided by Movistar-Panama. The official release of this important publication is programmed to take place in early 2010.

ACADEMIC COOPERATION FOR WETLANDS RESEARCH

During the first half of 2009, CREHO hosted, supported and supervised two students that carried out research on wetlands.



AVINA

Between March and June 2009, Betzuke Camargo, a student in Engineering Management from the University of Panama, worked on the project "*Characterization of Physical, Biotic and Social Resources of the Clayton Wetlands*", the area where CREHO has its headquarters.



Thanks to the economic support provided by the German Service for Academic Exchanges, from May to July 2009 CREHO hosted Jessica Gross, a student seeking a "Master of Tropical and International Forestry" at the Göttingen University, Germany, who carried out field studies in collaboration with ANAM and ARAP, together with two students from the University of Panama, Samuel Mojica and Alvaro Espinoza, in an area of the Golfo de Montijo Ramsar Site, Veraguas Province, Panama. The project is called "Capture of Superficial Carbon from the Mangrove Forests, Golfo de Montijo, Panama".



INTERNATIONAL COURSES ORGANIZED BY CREHO


CREHO has successfully carried out a total of six specialized courses of international character with a total participation of 108 professionals tied to wetlands from 28 countries, proceeding from the governmental sector, NGOs, academia, and the private sector.

I INTERNATIONAL COURSE ON WETLANDS MANAGEMENT: FORMULATION OF MANAGEMENT PLANS

2004

The course was realized in Merida, Mexico, from November 12 - 24, 2004. A group of 15 professionals participated in this course including Ramsar Focal Points in its respective countries (Argentina, Bolivia, Chile, Costa Rica, Cuba, Ecuador, El Salvador, Honduras, Panama, Peru, Mexico and Dominican Republic). The course was dictated in Spanish, and the 15 participants were granted a 100% scholarship.



II INTERNATIONAL COURSE ON WETLANDS MANAGEMENT: FORMULATION OF MANAGEMENT PLANS

The course was realized in Río Hato, Panama, from October 8 - 18, 2006. The Focal Points of 10 countries from the Western Hemisphere participated, the majority from the Caribbean Region (Antigua and Barbuda, Bahamas, Barbados, Belize, United States, Jamaica, Santa Lucia, Suriname, Panama, Trinidad and Tobago). The participants elaborated a series of recommendations for the Handling Plan for the Ramsar Site Gulf of Montijo. The course was dictated in English and 18 participants were granted a 100% scholarship.







I INTERNATIONAL COURSE ON ENVIRONMENTAL IMPACT ASSESSMENT AND ENVIRONMENTAL STRATEGIC ASSESSMENT FOR WETLANDS MANAGEMENT

Carried out in Panama City, Panama, from November 19 to December 5, 2007, and was attended by 22 participants from 11 countries in the region (the Dutch Antilles, Colombia, Costa Rica, Cuba, Ecuador, Guatemala, Honduras, Mexico, Panama, Paraguay, and Peru). Professionals from governments, the private sector, NGOs, Ramsar Focal Points, and members of National Wetlands Committees participated. Of the participants, twelve (12) received scholarships to the 100%; six received (6), partial scholarships; and four (4) did not receive scholarships of any kind (they paid tuition and covered their personal expenses of transportation, lodging and food). The course was dictated in Spanish.

> REGIONAL WORKSHOP FOR POLICY MAKERS OF LATIN AMERICA ABOUT "THE EFFECT OF DECISIONS ON WETLANDS AND THOSE MIGRATORY SPECIES: Managing and Wise Use of Natural Resources"

Carried out in Panama City, Panama, from August 25-29, 2007. It focused upon representatives from Government, Ramsar Focal Points, CMS Focal Points, and members of National Wetlands Committees. It was attended by 20 participants, all receiving 100% scholarships, representing 18 countries (Argentina, Brazil, Colombia, Costa Rica, Cuba, Chile, Ecuador, El Salvador, Guatemala, Honduras, Nicaragua, Panama, Paraguay, Peru, Dominican Republic, Uruguay, and Venezuela). CREHO co-organized the workshop along with the CMS Secretariat.









II INTERNATIONAL COURSE ON ENVIRONMENTAL IMPACT ASSESSMENT AND ENVIRONMENTAL STRATEGIC ASSESSMENT FOR WETLANDS MANAGEMENT

It was carried out in Panama City, Panama, from November 24 to December 5, 2008, and attended by 18 participants representing 7 countries of the region (Antigua and Barbuda, Argentina, Chile, Mexico, Panama, St. Lucia and Venezuela), the 8 participants that were not from Panama received 100% scholarships; whereas, the other 10 participants were part of the ARAP staff, and the institution covered their costs of participation. Professional representatives from the government, NGOs, Ramsar Focal Points, and academia participated. The course was bilingual (Spanish and English).

I CENTRAL AMERICA WORKSHOP OF SWAMP BIRDS MONITORING

It was realized in Costa Rica, in the Palo Verde National Park from December 7- 11, 2008. The workshop was dictated in Spanish and in attendance were 15 professionals from the governmental sector, NGOs, private sector, academia, and National Wetlands Committee, representing 7 countries of the region (Guatemala, Nicaragua, Honduras, El Salvador, Panama, Costa Rica, and Colombia). All received 100% scholarships. CREHO co-organized this workshop along with the Waterbird Conservation Council for the Americas, with the support of USFS, the National Museum of Costa Rica, USFWS and PRONATURA Northeast (Mexico).





PREPARATION FOR CREHO'S TRAINING OF TRAINERS COURSE

During the first half of 2009, the proposal for the training of trainers' course was made, with the purpose of forming a group of trainers on wetlands. With that in mind, work was carried out identifying and making contact with a group of specialists about wetlands in the Americas to determine their interest and availability to participate in such a course and, later, to become part of the team of instructors for the permanent courses organized by CREHO.




Courses and National Workshops Organized by CREHO



WORKSHOP OF INSTITUTIONAL STRENGTHENING FOR GITEC

2005 This workshop was carried out in January 2005 at Montijo, Province of Veraguas, Panama. Six members of GITEC participated in the workshop.

WORKSHOP "COASTAL WETLANDS AND EVALUATION OF ENVIRONMENTAL IMPACT WITHIN THE FRAMEWORK OF THE RAMSAR CONVENTION AND ITS APPLICATION IN THE HYDROCARBON SPILL"

It was carried out in Panama City, Panama, from September 25-27, 2006. 32 professionals attended, both civil servants from the government and NGOs. CREHO coordinated and co-financed the workshop along with the Maritime Authority of Panama. The Workshop was dictated in Spanish.

MEETING OF ENVIRONMENTAL EDUCATION FOR THE CARIBBEAN-COLOMBIAN REGION: "CONTRIBUTION OF THE ENVIRONMENTAL EDUCATION IN THE CONSERVATION OF WETLANDS ECOSYSTEMS AND COASTAL ZONES"

It was carried out in Colombia, Coveñas, Sucre, from October 23- 25, 2006. At this meeting, 59 participants attended, both civil servants from the government and representatives of NGOs. The event's objective was come to an agreement concerning actions for environmental education and to the implementation of the National Policy for Inner Wetlands of Colombia, articulated with the CEPA Program of the Ramsar Convention. The Environment, Housing and Territorial Development Ministry of Colombia organized the event with the endorsement of the Netherlands Embassy through the Program of Environmental Management Support in Colombia, the Regional Environmental Authorities of Corpomojana, Carsucre and CREHO.







FORUM "THE FISHING INDUSTRY, TOOLS FOR A SUSTAINABLE FUTURE"

It was carried out in Panama City, Panama, on November 20, 2006, and focused on the fishing sector. This workshop analyzed approaches and tools to improve the practices of the Panamanian fishing industry. The forum was attended by 12 participants and organized by CREHO with the support of Global-Compact Panama.

COURSE "INTRODUCTION TO THE WETLANDS MANAGEMENT WITHIN THE FRAMEWORK OF THE RAMSAR CONVENTION"



It was carried out in Panama City, Panama, from December 12- 15, 2006. This course provided a conceptual framework of the Ramsar Convention and its technical guidelines for handling plans, the EIA, and environmental education. 19 participants attended the event, including members of the ANAM staff and members of the Panama National Wetlands Committee, who within the framework of the workshop formulated an annual plan of action. The course was organized by CREHO thanks to the economic support of AVINA Foundation.





More than 2000 people have reached through events, such as courses, symposiums, forums, workshops, among others, that were organized by other institutions and in which CREHO has been invited to collaborate as a speaker.



PRESENTATION OF THE BAY OF PANAMA AS A NEW RAMSAR SITE

Taking place on January 26, 2004 with an attendance of approximately 50 people. The event was organized by ANAM and Panama Audubon Society.

WORKSHOP OF INTRODUCTION TO STRATEGIC PLANNING

It was carried out in Panama in February 2005. The workshop was directed at the Solidarity Network of Organizations and 10 participants attended.

COURSE "MANAGING WATER AND WATER RESOURCES THROUGH IMPLEMENTING THE RAMSAR CONVENTION"

A side event of the Summit on Sustainable Development (SSD13). It was carried out on April 18, 2005 in New York, USA and organized by the Ramsar Convention along with the Wetland Training Service of the Dutch Institute for Inland Water Management and Waste Water Treatment. The attendance was approximately 20 individuals coming from participant countries of the SSD 13.


WORKSHOP "INTRODUCTION TO THE ENVIRONMENTAL FLOWS"

Carried out in Buenos Aires, Argentina, from June 20- 30, 2006. Approximately 60 participants from the juridical offices of Environment Ministries of Latin American countries took part in the training organized by PNUMA-ROLAC.

II MESOAMERICAN PROTECTED AREAS CONGRESS SYMPOSIUM: REGIONAL STATE POLICIES, REGIONAL INITIATIVES AND INTERNATIONAL AGREEMENTS FOR CONSERVATION AND SUSTAINABLE DEVELOPMENT



It took place in Panama City, from April 24 - 28, 2006. CREHO presented "Regional Initiatives in Wetlands of International Importance" with emphasis in the Regional Strategy for Conservation and Sustainable Use of High Andean Wetlands and the Central American Policy for the Conservation and Wise Use of Wetlands. The attendance was around 100 participants. CREHO also participated in the workshop "Integration of IBAs into existing initiatives of conservation in Mesoamerica" where CREHO tied this subject to the Ramsar Convention. 30 participants attended this workshop organized by Birdlife International.





XI LATIN AMERICAN AND CARIBBEAN REGIONAL MEETING OF THE COUNTRIES PARTY TO THE UNITED NATIONS CONVENTION TO COMBAT DESERTIFICATION

Carried out in Panama City, Panama, from July 17-21, 2006. CREHO, by allocation of the Convention Secretariat, presented on the Ramsar Convention and the Regional Strategy for Conservation and Sustainable Use of High Andean Wetlands with an attendance of more than 100 people.



I SYMPOSIUM OF WETLANDS OF ECUADOR

It was carried out from July 24 - 28, 2006. The proposed objective was the integration of scientific and technical contributions to the conservation of wetlands in Ecuador. CREHO participated within the framework to strengthen the knowledge and use of the guidelines and technical guides of the Ramsar Convention. Participation exceeded 100 attendees.

CONFERENCE ON BUILDING CAPACITIES FOR THE SUSTAINABLE MANAGEMENT OF COASTAL- MARINE RESOURCES

Took place in Panama on November 13, 2006. The event of international character was conducted within the framework of the meeting of the Committee for the Creation of Capacities for Coastal Management of the Academy of Sciences of the USA. The result of this conference was the publication "Increasing Capacity for Stewardship of Oceans and Coasts" from the National Research Council. The conference totaled approximately 100 participants.

II SYMPOSIUM OF WETLANDS OF ECUADOR AND I INTERNATIONAL SYMPOSIUM OF LATIN AMERICA AND THE CARIBBEAN WETLANDS

2007

The symposium was carried out from August 1- 4, 2007, in Cuenca, Ecuador. For the second consecutive year, CREHO participated as a speaker within the framework of strengthening the use of the technical guidelines of the Ramsar Convention. Approximately 200 participants were in attendance.

FORUM WITHIN THE FRAMEWORK OF THE CELEBRATION **OF MANGROVE ECOSYSTEM DEFENSE DAY**


CREHO realized the presentation "What are Mangroves? And what benefits do they offer us?". This event was organized by several groups of the environmental civil society in Panama on July 23, 2008, in the Tupper Center of the STRI, Panama City, and 60 people attended.

WORKSHOP ON ENVIRONMENTAL IMPACT EVALUATION

The workshop was directed at the technicians staff of the Authority of the Aquatic Resources of Panama that at the national level are in charge of evaluating the Environmental Impact Studies. 50 participants attended, and it was carried out in Panama City on August 16, 2008.

FIRST CONVENTION ON WETLANDS OF THE ASIAN CHAPTER OF THE SOCIETY OF WETLANDS SCIENTISTS

It was carried out in the City of Taipei, Taiwan, from October 23 - 26, 2008. During this event, CREHO participated by offering a report, which cited the activities and benefits of CREHO in the Americas, Attendance exceeded 300 participants.



Carried out on October 28, 2008, in the Changwon National University, Province of Gyeongnam, South Korea and attended by approximately 100 participants.







PARTICIPATION OF CREHO AS A GUEST TO EVENTS ORGANIZED BY THIRD PARTIES

CREHO participates in events related to wetlands issues organized by other institutions. As CREHO's headquarters are located in Panama, most of the events attended were held in this country.

INTEGRATED MANAGEMENT OF RIVER BASINS WORKSHOP

2004

Realized in Panama on January 29, 2004, and was organized by UICN-ORMA for its partners in this country.

REGIONAL CONSULTATION WORKSHOP OF THE WORLD PROGRAM OF ACTION (WPA) FOR THE WIDER CARIBBEAN

Took place in Panama, in February 2004. Organized by CATHALAC / GPA / UNDP / NOAA / ANAM.

STRI MONTHLY CONFERENCE

The theme of the meeting held on April 23, 2004, was "Sustainable Development - Projects Executed in Panama".

III SYNERGIES OF CCAD TECHNICAL COMMITTEES MEETING

The third meeting of synergies of the Technical Committees on wetlands of the Central American Commission of Environment and Development was carried out in San Salvador, El Salvador, from September 21- 23, 2004. CREHO participated as a guest and undertook a presentation on the state of the centre's progress. The committee members expressed their support for the CREHO management.

In March 2005, CREHO participated in consultations conducted by ANAM for the preparation of this document.

LATIN AMERICAN AND CARIBBEAN REGIONAL WORKSHOP ON COMPLIANCE AND ENFORCEMENT OF MULTILATERAL ENVIRONMENTAL AGREEMENTS (MEAS)



Took place in Mexico from March 7-10, 2005. After consulting with the Convention Secretariat, CREHO gave a presentation about the Ramsar Convention. The workshop was part of a process that concluded with a document entitled "Manual of Compliance Whit and Enforcement of Multilateral Environmental Agreements" UNEP (2006). Approximately 50 participants attended.



WORKSHOP ON "IDENTIFICATION AND COUNTING SHOREBIRDS"

RAMSAR COP9 SIDE EVENTS

CREHO attended two side events of the Ramsar COP9. The event was organized by Wetland Link International "WWT Wetland CEPA in Action" where about 40 people participated. The second event was the Meeting of the Ramsar Regional Center for Central and West Asia with representatives of member countries in Asia, which was attended by around 20 people.



CMS CONTRACTING PARTIES CONVENTION

CREHO participated in the Latin America and the Caribbean Regional Meeting, which took place in Nairobi, on November 22, 2005. CREHO gave a presentation about the organization and the priorities for training. As a result, were co-organized in 2007, the Regional Workshop for Policy Makers of Latin America where 12 high-level participants attended.

2006 WHMSI CONFERENCE

Took place in San Jose, Costa Rica, in January 2006 with the participation of 60 representatives of governments and NGOs. During the meeting, a regional proposal was elaborated and submitted to the GEF. Since this event, CREHO has actively participated in this initiative, in particular through its dissemination. Organized by USFWS and MINAE.






POSTERS ON WETLANDS

ELABORATION OF INFORMATIVE MATERIAL







PREPARATION OF INFORMATIVE MATERIAL




SUB-OBJECTIVE

3.1 Creation of a network for monitoring wetlands in the region, for processing, studying and exchanging pertinent information to assist decision-making.

REGIONAL INITIATIVES WITHIN THE FRAMEWORK OF THE RAMSAR CONVENTION

CREHO participated actively in the Ramsar Convention regional initiatives for the Americas with the objective of adding to, rather than duplicating efforts and combining efforts, beginning with high-priority processes for the region and taking advantage of existing capabilities.



CREHO participated in the Contact Group "Guidelines for Defining EHAA" First Workshop, which took place in Quito, Ecuador, on March 29- 30, 2004. As a result of the meeting, a draft of the EHAA was worked which included aspects of training.









WORKSHOP OF FORMULATION OF THE EHAA

In this workshop, held in Salta, Argentina, from February 12- 17, 2005, CREHO participated as part of the EHAA Contact Group. In the Plan of Action, training was included as an objective and CREHO's role was defined. In addition, CREHO became a member of the Monitoring Committee of financial issues associated with the strategy formulation.

WORKSHOP FOR THE FORMULATION OF THE FINANCIAL STRATEGY OF THE EHAA

Took place in Iquique, Chile, in May 2006. CREHO supported with the formulation and edition of the final documents, with which a regional proposal for the High Andean Wetlands was developed to be presented to potential funding sources. Representatives from 8 countries (Argentina, Chile, Peru, Bolivia, Ecuador, Colombia, Venezuela, Costa Rica) participated in the workshop, as well as the Paramo Group, the High Andean Flamingos Group and Ramsar partner organizations (IUCN and WWF).

Commencement of Action within the FRAMEWORK OF THE EHAA

Within the Objectives 2 and 4 of the EHAA, in reference to the subject of capacity strengthening, CREHO presented an analysis of the need for strengthening, to thereby increase the base of information, in order to design a capacity strengthening plan specific to High Andean wetlands. The first results of the systematization of the information were presented to the EHAA Contact Group at the meeting that was held in Merida, Mexico in September 2007.

CREHO JOINS THE REGIONAL INITIATIVE OF THE PLATA RIVER BASIN CONTACT GROUP

In 2007, CREHO joined the Regional Initiative of the Plata Basin Contact Group by invitation from the group's member countries (Argentina, Bolivia, Brazil, Paraguay and Uruguay).

SUPPORT OF BIRDLIFE INTERNATIONAL PROPOSAL



CREHO supported Birdlife International's proposal draft, prepared within the framework of EHAA, supported as well by the Waterbird Conservation Council for the Americas and the Government of Ecuador. The proposal was presented to the Neotropical Migratory Bird Conservation Act in November 2007.

NATIONAL AND REGIONAL NETWORKS AND OTHER REGIONAL INITIATIVES

INTERNATIONAL CENTER FOR SUSTAINABLE DEVELOPMENT (CIDES)

CREHO subscribes to CIDES and participated in the workshop where this network was created, held in Panama City, Panama from July 21- 23, 2004.

WETLANDS LINK INTERNATIONAL AND THE TNC LEARNING CENTER

CREHO established contact with international environmental networks, with the aim of identifying opportunities for implementation of joint actions, it subscribes to two regional networks with a focus on training issues and the environment. These networks are: Wetlands Link International and TNC Learning Center.

PANAMA'S NATIONAL WETLANDS COMMITTEE

The ANAM, with support from CREHO, facilitated the process for establishing the Panama National Wetlands Committee. Similarly, CREHO organized in May 2006, an advising meeting and exchange of experiences between members of the Panama National Wetlands Committee, representatives and focal points from the Governments of Ecuador and El Salvador, and the Ramsar Convention Secretariat.



PARTICIPATION IN THE UNITED STATES NATIONAL RAMSAR COMMITTEE

At the workshop held in Uncertain, Texas, in November 2007, CREHO proposed the development of a simple induction guide for personnel working in wetlands declared as Ramsar sites. The preparation of the guide began in 2009.

WATERBIRD CONSERVATION COUNCIL FOR THE AMERICAS

CREHO participated as a member at the meeting that took place in Quito, Ecuador, from January 15 - 19, 2007. At this meeting, CREHO was offered to support in the area of training.

PANAMA'S NATIONAL WETLANDS COMMITTEE

During 2007, CREHO supported the Panama's National Wetlands Committee with the convocation of monthly meetings and by providing facilities for such meetings. Also it collaborated with the procurement of information, contacts and follow-up on key issues. Importantly, thanks to the Panamanian National Wetlands Committee the identification of potential new Ramsar sites was facilitated as well as the declaration of protected area of other areas with significant wetlands within Panamanian territory. In addition, Panama's National Wetlands Committee provided technical advice during consultations on the impact of development projects in wetlands.

WESTERN HEMISPHERE MIGRATORY SPECIES INITIATIVE (WHMSI)

CREHO designed the website for the initiative. The presentation of www.whmsi.net was made at the Third WHMSI Conference, held in Paraguay from July 22- 25, 2008.

In 2009, CREHO was invited to become a member of the Technical Advisory Committee in charge of establishing the guidelines for the formulation of a proposal for Panama.

2007 On January 2007, the Documentation Center on Wetlands, a specialized library on the subject of wetlands, opens to the public.

The Documentation Center on Wetlands provided attention to those who approached it to consult bibliographical references. In 2008, CREHO contacted the National Library of Panama, for advice on different options for the systematization of the information contained in this documentation center, which continues to grow every day thanks to the various publications that CREHO has received through donations from the public and private entities around the world.

CREHO and UICN-ORNA signed on February 2, 2005, a framework agreement for cooperation between institutions.

VISIT TO THE USFWS OFFICES IN WASHINGTON



USFWS financed the visit with the objective of establishing future partnerships with key organizations and identifying potential partners or donors. The visit took place from May 9- 13, 2005. USFWS has been a strategic ally of CREHO in fulfilling our training goal through the aid of its international program "Wildlife without Borders" for Latin America and the Caribbean.

ESTABLISHMENT OF CONTACT WITH WETLANDS INTERNATIONAL

WI contacted CREHO in order to develop a joint proposal and make a visit to the Canadian Cooperation Agency. In 2007, conversations to create an alliance began. In December, CREHO attended the sixth meeting of the Association of Members and Symposium Healthy Wetlands Healthy People. Events were organized by WI and held in China. In late 2008, the Program Office for Latin America of WI was established within CREHO's facilities in the City of Knowledge, Panama.

SUBSCRIPTION TO THE UNITED NATIONS GLOBAL COMPACT

On February 1, 2007, CREHO subscribed to the UN Global Compact. Since then, it participates in the activities developed by the Global Compact Network, Panama Chapter.

MEMORANDUM OF UNDERSTANDING WITH WHMSI

On July 22, 2008 during the Third WHMSI Conference Which was held in Paraguay, CREHO signed a Memorandum of Understanding with WHMSI based upon the premise that both initiatives will identify ways of working together using their strengths

FOLLOW-UP TO OTHER POTENTIAL AGREEMENTS

CREHO started preliminary conversations with IMWEN and Cooperative Institutes of Taiwan. Similarly, drafts of the agreement with the Ramsar Regional Center of Korea and the other with CONANP were prepared. Also, it engaged in conversations with the Panama Audubon Society for a possible agreement. CREHO established contacts with specialists in subjects regarding Wetlands for future collaboration.

CHANGWON DECLARATION NETWORK MEETING

On November 18 - 19, 2009, CREHO attended the first meeting of the Changwon Declaration Network that took place in Chagwon, Korea. The Changwon Declaration is a manifest characterized by its acknowledgement of the importance of wetlands as an important natural infrastructure in the water cycle, as well as a determining factor for the development of pertaining national strategies and plans to address issues related to climate change. The meeting was organized by the Ramsar Regional Center - East Asia, with the support of the Korean Environmental Ministry. During the meeting, advances made in the implementation of the Declaration were presented, and mechanisms to promote the Declaration were proposed.

31ST MEETING OF THE RAMSAR STANDING COMMITTEE

At this meeting held in Gland, Switzerland, from June 6- 10, 2005. CREHO followed up its request for financial support from the budget of the Ramsar Convention for the triennium 2006-2008. The submission of this proposal was approved at the COP9 Ramsar.

CONFERENCE OF THE CONTRACTING PARTIES TO THE RAMSAR CONVENTION — COP9

CREHO attended RAMSAR COP9 sessions and regional meetings of the Americas as part of the support team for the Americas of the Ramsar Convention Secretariat. Similarly at the regional meeting of the Americas, CREHO talked about issues related to training needs and existing mechanisms to develop a training program in the Americas. At this meeting, CREHO distributed digital and printed material to all participants (about 50). In addition, CREHO followed up the approval of the budget allocation of regional initiatives for the triennium 2006-2008.

2006 CREHO participated in the Ramsar Standing Committee of the Ramsar Convention Meeting, carried out in Gland, Switzerland, from April 10- 13, 2006, providing follow-up for the regional initiatives.

Conducted in the Netherlands from June 20- 21, 2007. CREHO contributed in the process of formulation of the CEPA program for 2009 - 2015. The same was adopted by Ramsar COP10 Resolution by means of the Resolution X.8. CREHO attended this meeting representing the Ramsar Regional Centers.

4TH. MEETING OF THE ADVISORY BOARD ON

CAPACITY BUILDING FOR THE RAMSAR CONVENTION

Took place in Delft, the Netherlands, in June 2007. CREHO attended as an observer.

WORKSHOP "BUILDING CAPACITIES REGARDING WETLANDS"

Took place in Delft, the Netherlands, on June 19, 2007. It was a joint Workshop of the Advisory Board on Capacity Building for the Ramsar Convention and the CEPA Oversight Panel. At the workshop, technical concepts relating to building capacities were defined and granted approval and the roles between different actors in the topic were discussed.

CREHO participated in a workshop with teachers and community members of Tilapa, a Ramsar Site in Guatemala, with the objective of developing the adaptation of the environmental education on wetlands manual. The workshop was held on March 29 - 30, 2005 and involved 5 people. It was coordinated by Mangrove Action Project and Friends of the Forest (Coatepeque branch).

LATIN AMERICAN SEMINAR "PARTICIPATORY MANAGEMENT: LESSONS LEARNED FROM THE EXPERIENCE"

CREHO was a speaker. The seminar was held in Sarapiquí, Costa Rica, from September 23- 28, 2005. At this seminar a framework draft for action on Participatory Management was produced, included as additional support to Resolution VIII.36 for Ramsar COP9. It was coordinated by FUNGAP and approximately 20 participants attended from Latin American countries.

PROJECT OF CURRICULAR ADAPTATION FOR TEACHERS "THE WONDERFUL MANGROVES OF GUATEMALA"

CREHO participated in the workshop that was held in Ramsar Site Manchon de Guamuchal, Guatemala, from April 14 - 23, 2006. About 30 people attended this workshop, held especially for teachers and community members, where training was conducted in the use of the manual "The Marvelous Mangroves" with the objective that these activities would be included as part of the school curriculum. It was coordinated by Mangrove Action Project in conjunction with Friends of the Forest (Coatepeque branch) Report 2004-2009

SUPPORT TO OTHER ORGANIZATIONS

Additionally, CREHO has supported with technical guidance, information exchange and networking for various key stakeholders in the issue of wetlands both in the Western Hemisphere as well as the rest of the world.



"EVALUATING AND REVIEWING THE CRITERIA OF REPRESENTATIVENESS OF CIVIC NGO'S"

2004 For the preparation of this document, CREHO provided support to the Network of Active Citizen Participation and New Synergies in Development, providing precise information about Panama. **COLLABORATION WITH ANAM** CREHO participated in various meetings and consultation activities carried out in projects on issues and legislation 2005 (draft for system of protected wilderness areas law, among others). Besides, CREHO provided information on wetlands to the Promotion of Environmental Culture Department and the Regional office of the ANAM in the province of Veraguas. **BINATIONAL WETLANDS** Hugo Hidalgo, project coordinator of FUNDAECO for Coastal 2006 Marine, an NGO in Guatemala, made several consultations to CREHO concerning the guidelines established by the Ramsar Convention on binational wetland management.

CONSULTATION ON EFFECTS TO WETLANDS

The Parks Unit of the Ministry of Environment of Colombia consulted CREHO about the effects to which the Flamenco Park wetlands are prone.

WORKSHOP ON ENVIRONMENTAL EDUCATION ON WETLANDS



CREHO provided support in the preparation of the workshop on environmental education issues in wetlands. The workshop was conducted by the Ecosystem Directorate, Office of Education.

TECHNICAL SUPPORT



In September 2006, CREHO provided technical support to the AMP on a visit made to the coastal area of Vacamonte, Panama. It also provided technical support to a community group in the area of Montijo, Panama.


PARTNERSHIP FOR DEVELOPMENT OF PROPOSAL ON WETLANDS








INSTITUTIONAL DEVELOPMENT FRAMEWORK


CREHO has been concerned with self-assessment during its development and has used a tool known as the Institutional Development Framework (IDF). The IDF is a tool that in general aids an organization to:

- Consider what makes organizations successful
- Evaluate strengths and weaknesses in light of these factors
- Formulate a plan of priorities to sustain strengths and address weaknesses
- Measure progress against the objectives set by the organization itself
- Effectively convey a message for potential donors

Development, which started from zero in year one of operation (2004) and on which progress has been progressively and steadily made between 2004 and 2009.



GRAPHIC 15. PROCESS MEASUREMENT THAT UNDERLIES IDF



The first evaluation with this method was conducted in January 2004, the second in November 2004, a third in March 2006 and a fourth in February 2009.

The priorities graphic, presents the priority of each aspect at any given time. The above mentioned is read from bottom to top and from left to right. We put a number in each quadrant to facilitate identification of priorities in each quadrant. Thus, we see that quadrant 1 is the highest priority and quadrant 4, the least priority.


In this sense, for example the appearance of higher priority would be "financial soundness" because the goal is further to the right in quadrant 1 (marked with a red circle in the graphic). In 2004, we see that most of the goals are a priority and this is understandable since it was a fledgling organization. By comparing the measurements, progress is evident since many of the targets in 2004 in quadrant 1, are now located in quadrant 2 on the assessment made in 2006.

CREHO'S STAFF TRAINING

2004 From March 3 – 11, 2004, the Executive Director, Rosa Montañez, visited the Convention Secretariat headquarters, in Gland, Switzerland, for induction sessions on the Ramsar Convention. This training was funded by USFWS.

> From April 4 – 22, 2005, Maria Rivera, Ramsar Focal Point in Colombia and later CREHO Technical Officer (June 2006 - April 2007), assisted with funding from CREHO and the Ramsar Secretariat, to the International Training of Trainers course on wetland management. The workshop focused on training in facilitating processes that involve stakeholders and curriculum development. The knowledge gained laid the basis for the development of the permanent courses currently offered by CREHO. The course was dictated by ICWM-TOT, the Netherlands.



In May 2007, the Administrative Assistant, Digna Gonzalez, received training in the use of the Peach Tree Software, 2007 which is used to make records. This service was given by the external accountant of CREHO. From November 15 – 22, 2008, the Communications Assistant, Cristina Tzanetatos, by invitation from the organizers participated in Environmental Education Training Workshop on the Use of the "Wondrous West Indian Wetlands: Teachers' 2008 Resource Book". The workshop was held in St. Croix, Virgin Islands, and was organized by the Society for the Conservation and Study of Caribbean Birds and the Wetlands Conservation Project. This invitation was received under the framework of the Waterbird Conservation Council for the Americas. On March 31, 2009, the Communications Assistant, Cristina Tzanetatos, attended the Project Development Workshop on 2009 using the Logical Framework approach. The workshop was held in Panama City and was organized by the Global Compact Network. Facilitator Inola Mapp, Associate Consultant to the Network.



From June15- 22, 2009, the Administrative Assistant, Digna Gonzalez, was trained by staff from the National Library of Panama in the use of ISIS software for cataloging publications, and in El Dorado, for creating digital libraries. Both were developed by UNESCO for free use in public libraries. With this tool, the digitization of a select group of publications of CREHO's Wetland Documentation Center was initiated.

BOARD OF DIRECTORS

The Board of Directors is the highest governing body of CREHO's hierarchy. It is composed of representatives of the signatories countries to the Ramsar Convention in the Western Hemisphere, the Ramsar Convention Secretariat, Ramsar partner organizations, scientific institutions, and the National Environmental Authority of Panama on behalf of the host country.

ANNEX 1. CREHO'S BACKGROUND

1997	Chronology of Important Events
1337	The Government of Panama in the 20th Meeting of the Ramsar Standing Committee, held in Gland, Switzerland, in 1997, presented the initiative to establish the Ramsar Regional Center for Training and Research on Wetlands in the Western Hemisphere, taking advantage of the benefits and facilities of the country in the City of Knowledge.
1998	The Central American Commission for Environment and Development, comprising the Ministers of Environment of Central America in its XXIV Regular Session, held in Belize in 1998, endorsed the establishment of the Center.
	The First Pan American Meeting of the Ramsar Convention, held in Costa Rica in June 1998, issued a decision supporting this initiative by the Government of Panama.
1999	The seventh Conference of the Contracting Parties to the Ramsar Convention held in San Jose, Costa Rica, from May 10 - 18, 1999, adopted by Resolution VII.26 "Establishment of the Ramsar Regional Center for Training and Research on Wetlands in the Western Hemisphere "because of its importance for the implementation of the principles of the Convention and the contribution to the development of actions envisaged in its Strategic Plan.
2002	During COP8, held in Valencia, Spain, in 2002, consolidated the installation of the Center for consensus on the signing of an agreement between the Ramsar Secretariat and Panama, to assist efforts in the management of resources and development of the Center. Making the Center a commitment to the region, whose operations fill an important need for training and research of the countries.

On January 31, 2003, ANAM and CATHALAC signed an agreement for the provisional establishment of CREHO within its facilities.

On February 28, 2003, the Convention between the Government of the Republic of Panama and the Office of the Convention on Wetlands of International Importance Especially as Waterfowl Habitat was signed, for the creation of and operation in Panama the Ramsar Regional Center for Training and Research on Wetlands in the Western Hemisphere.

On January 5, 2004, the Ramsar Regional Center began operations, after a process of several months during which the Government of Panama facilitated the process of selecting the Executive Director and allocated the budget as seed money for the operation of the Center for the first year in the amount of U.S. \$ 82,600, from a total of \$510,000 over 10 years, which had been established as an approximate total commitment of the Convention Framework.

On July 20, 2004, the July 7, 2004 Official Gazette No.25, 097 of Law No.33 was published, whereby the Government of Panama ratified the agreement signed with the Bureau of the Convention on Wetlands of International Importance.

In 2004 with the aid of AED, the logo and CREHO acronym were designed. Technical actions were begun.

During 2005 the action areas through a Regional Assessment and Strategic Plan were defined.

2007—2008	 Between 2007 and 2008 two permanent international courses for marketing to the public were established: 1) Environmental impact evaluation and strategic environmental assessment for wetland management, 2) Managing Wetlands: formulating management plans. The facilitation of concrete processes and on-site capacity building commences, in the form of models to generate lessons learned to be replicated. Growth begins as well as the monitoring of the impact of their interventions.
